

Minutes

May 6, 2015 94th Aero Squadron Restaurant

President, **Jon Burgess**, Councilman, City of Homestead, called the meeting to order at 7:15 p.m. and welcomed the guests to the 94th Aero Squadron. First Vice President, **Francis Suarez**, Commissioner, City of Miami asked Circuit Court **Judge Robert J. Luck**, Eleventh Judicial Circuit to give the invocation. Councilman, **Seth Salver**, Village of Bal Harbour, led us in the Pledge of Allegiance.

President **Burgess** asked for a motion to approve the minutes and the consent agenda. The motion passed by unanimous vote.

President Burgess introduced Miami-Dade County Commissioner, Rebeca Sosa, and presented Commissioner Sosa with the President's Public Service award on behalf of Immediate Past President, Mayor Cindy Lerner. President Burgess thanked Commissioner Sosa for her service, and for always opening her doors to the League. He mentioned that Mayor Lerner along with League Executive Director, Richard Kuper met Commissioner Sosa when she was the Commission Chair on several occasions to discuss sustainability, annexation/incorporation, and transportation, among other issues. Commissioner Sosa was always receptive to the League issues. President Burgess also read a letter provided by Mayor Muhiña of the City of West Miami expressing his and his colleague's congratulations to Commissioner Sosa for this recognition. He also informed the attendees that due to a specially set commission meeting they would not be able to attend the meeting and participate. Commissioner Sosa accepted the award, thanked Immediate Past President, Mayor Lerner, President Burgess, the board and the League for this honor. She was very grateful and reminded us that she was very grateful and reminded us that she always has an open door and the League and their issues are important to her.

President Burgess introduced Councilman James McDonald and First Vice President Francis Suarez to discuss the MPO. Commissioner Suarez and Councilman James McDonald spoke of the article they co-authored, and that was printed in the Herald's Editorial Page. Councilman McDonald mentioned that traffic is one of the major issues facing our County, and that they would like to propose that the MPO be re-organized so that it positively impacts the County and all municipalities. Councilman McDonald also mentioned that the Transportation Committee would like to engage in conversation with the local elected officials to be able to go back to the Legislature and receive a unified fund to change and make the MPO a better structure for the citizen's of Miami- Dade County. As chair of the MDCLC transportation committee he will continue to work on this issue and keep us informed.

President **Burgess** introduced **Dr. Jeffrey Horstmyer**, American Heart Association. Dr. Horstmyer spoke of "May stroke month" and how to prevent strokes. Dr. Horstmyer mentioned the decreased percentage of stroke death and what procedures to take when having a stroke to receive proper and effective treatment. President Burgess thanked Dr. Horstmyer for his presentation.

President **Burgess** introduced **Mr. Chad Friedman**, Weiss Serota Helfman Cole & Bierman, P.L.. Mr. Friedman is the League appointee to the Jackson Memorial Hospital Bond Committee. Mr. Friedman spoke of the projects the Jackson Memorial Hospital Bond Committee are working on and thanked the League for appointing him to the committee. Mr. Friedman mentioned the 2013 tax payers approval for the tax increase to fund 830 million dollars in bonds to upgrade the Jackson Memorial Hospital health care system. So far, they have had 127 million dollars invested in improving the health care system. One of the largest improvements was the purchase of land to build a new health care facility in the City of Doral. Mr. Friedman stated that the committee was focused on technology and equipment, hospital upgrades, infrastructure, and new facilities and he looked forward to updating everyone again of the improvements being made.

President **Burgess** introduced Senior Vice President of Government Affairs **Ms. Danielle Blake** and Vice President of Government Affairs, **Councilwoman Ana Maria Rodriguez**, Miami Association of Realtors. Councilwoman Ana Maria Rodriguez informed everybody of a micro grant available through the Miami Association of Realtors and encouraged everyone to apply. A place making grant application was included in the agenda.

President Burgess introduced Executive Director, Richard Kuper for the Executive Director's Report. Mr. Kuper thanked everyone for attending the meeting. 
City of South Miami Resoltion No. 066-15-14405 was placed in the agenda for informational purposes.

Ten Reasons why you should consider hiring a ReServist:


- 1. You are writing a proposal and budget constraints do not allow for all your staffing needs.
- 2. You have a special event coming up and need additional experienced assistance.
- 3. You have a staff member on leave and need to temporarily fill that position.
- 4. You have a special HR/Comp project that needs to get done.
- 5. You need help transitioning from one database system to another or updating your website.
- 6. You need extra staff for children's programs, camp, afterschool, tutoring or mentoring.
- 7. You need to develop a new training program and need someone with specific industry skills.
- 8. You need someone to develop and implement a marketing, PR or community outreach program.
- 9. You want to implement a new billing system.
- 10. You have a seasonal project that requires intensive volunteer coordination and management.

The criteria for participation in a ReServe Partnership are:

- a. Partner must be a nonprofit or government organization.
- b. The ReServist's assignment is for a 120 hours, typically 10-15 hours a week for 3 months. ReServist assignments are based on the opportunity and needs of the partner.
- c. Partners pay ReServe a fixed rate of \$16 per hour for every hour the Reservist works. The third party employer of record pays the ReServist stipend, and covers FICA, Medicare and other payroll fees. ReServists are not on your payroll.
- d. Your organization will be billed based on the approved hours submitted by the ReServist. The ReServist is paid by the payroll company.

How to proceed if you feel a ReServist might be right for you:
