

RESOLUTION NO. 2012-1

A RESOLUTION OF THE EXECUTIVE BOARD AND BOARD OF DIRECTORS OF THE MIAMI-DADE COUNTY LEAGUE OF CITIES, INC. OPPOSING THE ENACTMENT OF PROPOSED SENATE BILL 840 OR SIMILAR LEGISLATION AUTHORIZING COUNTIES TO UNILATERALLY TERMINATE OR IMPOSE ADDITIONAL REGULATIONS UPON ACTIVE COMMUNITY REDEVELOPMENT AGENCIES; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, community redevelopment agencies ("CRA") within Miami-Dade County operate in accordance with the provisions contained within inter-local agreements between municipalities and Miami Dade County, which enumerate the delegation of powers between both entities and are entered into in good faith (the "Interlocal Agreements"); and

WHEREAS, the Florida Legislature is currently considering the adoption of Florida Senate Bill 840, which would unilaterally amend existing Interlocal Agreements, wresting local control of CRAs from their boards and local municipalities and granting those powers to Miami Dade County, including the ability to eliminate CRAs at will without the consent of the affected CRA or municipality; and

WHEREAS, the Miami Dade County League of Cities opposes Florida Senate Bill 840, or other similar legislation that would effectively authorize Miami-Dade County to unilaterally amend or terminate the Interlocal Agreements.

NOW, THEREFORE BE IT RESOLVED BY MIAMI-DADE COUNTY LEAGUE OF CITIES, INC., AS FOLLOWS:

Section 1. Recitals adopted. That the above stated recitals are hereby adopted and confirmed.

Section 2. Legislation Opposed. That the Miami-Dade County League of Cities, Inc., hereby expresses its opposition through its Executive Board of Directors to the enactment of Florida Senate Bill 840 or other similar legislation that would grant Miami-Dade County the authority to unilaterally amend or terminate existing Interlocal Agreements governing the creation and operation of community redevelopment agencies, and the Secretary of the Miami-Dade County League of Cities, Inc., is hereby directed to forward a copy of this Resolution to the Florida Legislature.

Section 3. Effective Date. That this Resolution shall take effect immediately upon the adoption hereof.
